
What Is The Bank Draft Program?

The Bank Draft Program from Horry Electric Cooperative makes paying your electric bill easier than ever. When you sign up for Bank Draft, Horry Electric will automatically draft your checking or savings account for the amount of your monthly electric bill.

You'll still receive monthly statements showing kilowatt-hour use and the amount due, but with Bank Draft, you won't have to write a check - ever! And your payments will be made on time, every time.

What Are The Benefits Of The Bank Draft Program?

With the Bank Draft program, you'll never have to remember to pay your bill. And since you'll receive a monthly statement, you can easily keep track of what was drafted out of your account. You won't have to write a check or pay for a stamp or remember to take the envelope to the mail box. Your account will not be drafted until the actual due date indicated on your bill. If that date falls on a bank holiday or weekend, it will be drafted the following business day. With everything else there is to worry about, isn't it nice to have one thing you can cross off your list?

BANK DRAFT AGREEMENT

I understand:

- Horry Electric shall not be responsible or liable for notifying me if the balance in my account is insufficient to pay the draft.
- The bank drafts will be electronically transmitted on my next available billing and I am responsible for any charges incurred by Horry Electric Cooperative, Inc. for bank drafts.
- I will be removed from the program if there are insufficient funds in the account at the time the account is drafted. At that time, the entire account balance, plus all applicable fees, will be immediately due. If removed, I will not be eligible to sign up for Bank Draft for 12 months.
